THIS AGREEMENT (hereinafter referred to as "Agreement") made and entered into as of 29th day of September, 2023 by and between Jacksonville Aviation Authority, a body politic and corporate existing under Chapter 2001-319 (Sp. Acts June 5, 2001) Laws of Florida, as amended (hereinafter referred to as the "Authority" or "JAA"), and WHC JAX, LLC, dba zTrip a Corporation authorized to do business in the state of Florida (hereinafter referred to as the "Operator.")

RECITALS

- **WHEREAS**, Authority owns and operates Jacksonville International Airport, located in Duval County, Florida; and
- **WHEREAS**, Authority issued a Request for Proposals, No. 23-14-43605 on April 17, 2023 for competitive proposals for the operation of On-Demand Transportation Services at the Airport; and
- **WHEREAS**, Operator has submitted a response to Authority's Solicitation for On-Demand Transportation Services at the Airport; and
- **WHEREAS**, Operator demonstrated the ability to properly finance, operate, and manage On-Demand Transportation Services in accordance with the terms and conditions of this Agreement; and
- **WHEREAS**, In reliance upon Operator's representations, JAA selected Operator amongst those most qualified to provide the requested service.
- **NOW, THEREFORE**, in consideration of the premises and of the mutual convents herein contained, and for such other good and valuable consideration, the receipt and sufficiency of which Authority and Operator hereby expressly acknowledge, Authority and Operator acknowledge that the foregoing recitals are true and correct and are incorporated into this Agreement by reference, and do hereby agree as follows:
