(“CONTRACTOR”) a corporation authorized to do business with the state of Florida with its principal office located at 200 Northstar Court, Sanford, Florida 32771.

WITNESSETH

That for the mutual promises and covenants herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. JAA issued a Request for Proposal (RFP) No. 22-08-45133 in order to procure a firm licensed, qualified, and interested in providing on-call roof and gutter repair services.
