THIS CONTRACT, is executed this 25th day of February, 2020, by and between JACKSONVILLE AVIATION AUTHORITY, (JA or AUTHORITY). and **JOHNSTONE SUPPLY** ("CONTRACTOR") with its principal office located at 11710 Central Parkway Jacksonville, Florida 32224.

WITNESSETH

That for the mutual promises and covenants herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. JAA issued an Invitation to Bid (1TB) No. 20-13-17111 in order to procure a firm licensed, qualified and interested in providing HVAC Supplies. No bids were received in response to 1TB 20-13-17111, therefore JAA proceeded to negotiate with the incumbent vendor Johnstone Supply.
2. Contractor submitted its proposal to JAA representing that it possesses the requisite licenses, skills, experience and capabilities to provide the necessary goods as required by the 1TB.
3. In reliance upon Contractor's representations, JAA has selected the Contractor as qualified to provide the requested goods.
4. JAA hereby engages the Contractor for the potential provision of the goods set forth in the Bid Form (**Exhibit A**), for which goods Contractor will provide as requested by JAA. Contractor will not provide any of the goods contemplated under this Contract until such time as it receives a written approval and notice to proceed from JAA. 
