Sealed bids will be received by the Jacksonville Aviation Authority Administration Building, 14201 Pecan Park Road, Jacksonville, Florida 32218 until **2:00 PM** local time, on **October 9, 2018** at which time they shall be opened in the JAA 2nd Floor Conference Room, 14201 Pecan Park Road, Jacksonville, Florida 32218, for:

**HERLONG RECREATIONAL AIRPORT
RUNWAY 11-29 AND TAXIWAYS C & D REHABILITATION**

This project includes the Rehabilitation of Runway 11-29 and Taxiways C & D, at Herlong Recreational Airport, in Jacksonville, Florida. The associated site work includes full depth asphalt pavement removal and building up lime rock base course, placing 4" of asphalt pavement on Runway 11-29 and Taxiways C & D. The existing excess asphalt pavement located around the Runway 11 End will also be removed, regraded, and replaced with topsoil and grass seed.

There will be a Pre-Bid Conference held at Herlong Recreational Airport, 9300 Normandy Blvd, Jacksonville, Florida 32221, on **September 18, 2018** at **2:00 PM**. There will be a site visit immediately following the meeting.

Bid security in the amount of five percent (5%) of the base bid will be required to accompany bids. Contract Bonding shall also be required. The Owner reserves the right to reject any or all bids and to waive irregularities in bidding. Participation in the Disadvantage Business Enterprises Program (DBE) is required. The goal for this contract is **fifteen percent (15%)** to be performed by certified DBE firms.

This project will be bid as a single contract. Bid prices may be held for up to 120 days. All bids must be submitted in accordance with the Project Manual for Contract No. C-834 which may be examined in the Herlong Recreational Airport Manager's Office, or obtained from:
