GARAGE & CURBSIDE FLOOR COATING**

Project includes the installation of a Methyl Methacrylate (MMA) flooring system at exterior covered and non-covered pedestrian walkway areas. Area of installation of MMA material includes curbside drop off areas at enplane and deplane levels, the pedestrian connector bridge from the parking garage, pedestrian connector in parking garage along moving walks, area immediately in front of elevators and other various pedestrian areas surrounding the terminal building. Areas in drawings have identified base bid areas and alternate areas.

There will be a Pre-Bid Conference held in the JAA Training Room of the Administrative Offices, 14201 Pecan Park Road, Jacksonville, Florida 32218, at **2:00PM on November 20, 2018**.

Bid security in the amount of five percent (5%) of the base bid will be required to accompany bids. Contract Bonding shall also be required. The Owner reserves the right to reject any or all bids and to waive irregularities in bidding. The Authority has determined that **NO SBE** participation goals will be prescribed for this project.
