### **Submitted Questions and Responses**

Question #1. Would JAA please remove all defense and alleged requirements, and

requirements to indemnify "agents" within any indemnification of the contract or RFQ? Defense is not covered by insurance and agents are not defined as to who

they are.

Response: No, this provision will not be removed.

Question #2. Would JAA please add a clause within section 1.1 of the sample agreement to

clarify the relationship of trust and confidence is not a fiduciary duty relationship? Suggested language is as follows: Notwithstanding the foregoing, no warranty, express or implied, is made or intended by Consultant's performance of services,

and it is agreed that Consultant is not a fiduciary with respect to the JAA.

Response: No

Question #3. Will a front cover identifying the RFQ by title and number be excluded from 20-

page limitation? The requirements stated cover letter, dividers, appendix forms,

business licenses, and references are excluded from the 20-page limit.

Response: The cover does not count towards the 20-page limit.

services? Or only to inspection services?

successful proposer and will include Items A through K of Section 5, Construction Phase, of the Scope of Services. Construction Management and Inspection services may also be requested, depending on JAA

workload.
