THE FOLLOWING ITEMS ARE MADE AND HEREBY BECOME A PART OF THIS SOLICITATION AS PREPARED BY PROCUREMENT:

REMOVE AND REPLACE

REMOVE Article III Scope of Services, Section 3.03 Engagement Contract in its

entirety.

REPLACE WITH Article III Scope of Services, Section 3.03 Engagement Contract

The terms and conditions of the financing transaction during the Term of Award will be governed by an Engagement Contract that will be issued by the Selected Respondent to JAA and agreed to and accepted by JAA. The designated Senior Manager for the Issue will negotiate takedowns and other fees with JAA prior to the Issue. The agreed and accepted Engagement Contract will include all provisions as written in Exhibit F,

Appendix A Title 6 and Other Provisions.

QUESTIONS & ANSWERS

- Q1: What is the anticipated size of the bond issuance? And should we use this par amount for purposes of calculating the fees and expenses?
- R1: For purposes of your response to this RFP and estimated fees and expenses, please assume a total par amount in the range of \$200 million to \$250 million but not to exceed \$300 million.
- Q2: What is the anticipated tax status of the bond issuance for purposes of providing pricing spreads?
- R2: A final tax analysis has not been completed, but the expectation is that the majority of the bonds will be subject to the AMT. However, JAA may also consider the issuance of a small non-AMT tranche, if practical. As such, please provide both AMT and non-AMT spreads.
- Q3: What is the anticipated time frame for pricing the bond issuance?
- R3: JAA is currently expecting that the bond pricing would occur in late Q1 or early Q2 during calendar year 2026.
- Q4: Can you provide a description of the project that the bonds will be funding and when that project is anticipated to be completed?
- R4: We are currently constructing a new airport Concourse, "Concourse B". It will be completed by December 2026. The project also encompasses the expansion of our security checkpoint and the extension of a taxiway associated with the new Concourse.
- Q5: Does the Authority have any additional near-term bonding plans beyond this financing?
- R5: Not currently.

- Q6: Can you provide the annual debt service schedule for the Authority's outstanding long-term debt (2021 bank note, 2021 private placement, 2024 direct placement, outstanding line of credit)
- R6: Attached.
- Q7: In Article IV Proposal Form, paragraph G references acceptance of a Purchase Order and invoice JAA. In the public capital market, underwriters are only paid upon closing of the bond issuance, and the underwriters' discount is netted out of the purchase price of the bonds. Can this paragraph be removed from the Proposal Form since it is not customary for bond underwriting services?
- R7: We plan on paying bond closing fees out of bond proceeds. Paragraph G has been removed, see attached Revised Article IV Proposal Form.
- Q8: In Article IV Proposal Form, paragraph H references acceptance of ACH Payments. As noted in the prior question, in the public capital market, underwriters are only paid upon closing of the bond issuance, and the underwriters' discount is netted out of the purchase price of the bonds. Can this paragraph be removed from the Proposal Form since it is not customary for bond underwriting services?
- R8: We plan on paying bond closing fees out of bond proceeds. Paragraph H has been removed, see attached Revised Article IV Proposal Form.
- Q9: For the Affidavit of Compliance with Florida Statutes Section 287.138 and 787.06, our legal team request the following addition to Paragraph 5: "To the best of the undersigned's knowledge and belief" in order for the lead representative to sign the form.
- R9: Per JAA Legal, this change is acceptable. Revised Exhibit B is attached.
- Q10: For Section 1.09, Mandatory Respondent Criteria, there is no guidance on requested documentation to verify meeting the minimum qualification. Is JAA requesting any documentation as part of the submittal, or will this be a potential follow up item after submittal of the RFP?
- R10: No documentation is required. The Authority's financial advisors, PFM Financial Advisors LLC, and MW Financial Advisory Services LLC, will verify whether Respondents meet the mandatory requirements of Section 1.09.
- Q11: How would JAA like respondents to acknowledge addendum #2 since there is only space for one acknowledgement in Article IV Proposal form? Should we just add an additional line to the form?
- R11: Respondent's may enter the number for each issued Addenda in the space provided for Addendum No. for example: Addenda No. 1,2,3.
