**FIRST AMENDMENT
TO THE

AND
SIXT RENT A CAR, LLC**

THIS FIRST AMENDMENT TO THE AIRPORT RENTAL CAR LEASE AND CONCESSION AGREEMENT AT JACKSONVILLE INTERNATIONAL AIRPORT ("First Amendment") is executed and effective this 23rd day of August, 2023, by and between the **JACKSONVILLE AVIATION AUTHORITY**, a body politic and corporate, created and existing under Chapter 2001-319 Laws of Florida (Sp. Acts. June 5, 2001, as amended), ("Authority") and **SIXT RENT A CAR, LLC**, a foreign limited liability company organized under the laws of the State of Delaware and authorized to do business in the State of Florida (hereinafter referred to as the "Concessionaire").

RECITALS:

WHEREAS, On June 1, 2023, the Authority and Concessionaire entered into an On-Airport Rental Car Lease and Concession Agreement for a Term of five years with one five-year optional Term; and

WHEREAS, Authority and Concessionaire seek to amend the Agreement primarily associated with Authority's Board of Directors' passage and approval of a Resolution regarding the establishment, implementation, administration and reporting of a new Customer Facilities Charge; and

WHEREAS, the Parties also desire to correct a scrivener's error regarding Concessionaire's company name / corporate type in the introductory paragraph.

NOW THEREFORE, THE PARTIES, BASED UPON MUTUAL CONSIDERATION, THE SUFFICIENCY OF WHICH IS ACKNOWLEDGED, AGREE AS FOLLOWS:

1. As illustrated in the introductory paragraph, the parties hereby correct the scrivener's error contained in the introductory paragraph of the Agreement. More specifically, Concessionaire's company name / corporate type is changed from Sixt Rent A Car, LLC, a corporation to Sixt Rent A Car, LLC, a foreign limited liability company.
2. **RECITALS.** The above recitals are true and correct and are hereby incorporated herein.
