#### **BACKGROUND:**

Allegiant Airlines has started flying nonstop from Jacksonville International Airport (JAX) to two new destinations: Harrisburg, PA; and Knoxville, TN. As part of the air service incentive program, the Jacksonville Aviation Authority (JAA) endeavors to promote all new routes for the first two years of their operation. These are new markets that qualify for the program. Allegiant's success on these routes means additional capacity at JAX, lower fares for the community and new nonstop markets.

Allegiant currently has a marketing relationship with R&R Partners, its agent-of-record, from which relationship JAA desires to benefit, particularly as it relates to continued and consistent advertising promotions and similar services relating to JAX. The agency has secured outdoor billboard and digital posters advertising to promote the new nonstop flights in the outbound markets.

This award was to be presented in October or November; however, due to prior scheduled international travel the Marketing department was unable to present. This award is for the ratification of the past due invoices on PO No. 61136 schedule for payment this month. This award request is exempt from competition pursuant to § 2.05(A)(14) of JAA's Procurement Code.

#### **RECOMMENDATION:**

Marketing recommends that JAA make a properly noticed award, pursuant to § 2.05(A)(14) of the Procurement Code, to R&R Partners, as agent-of-record for Allegiant Air, for airline supplemental advertising of various platforms, in a not-to-exceed amount of \$37,475.99. #### **BACKGROUND:**

The Jacksonville Aviation Authority (JAA) seeks to enhance its internal controls by broadening the review of its own internal processes. Previously, JAA utilized our Revenue Compliance Specialist role to perform functions typically associated with internal audit services. At times, this has been augmented by one-off process reviews performed by an external accounting firm.

With the resignation of our Revenue Compliance Specialist, JAA has determined that the timing is right to outsource our internal audit service function. Fully outsourcing the function will provide JAA with a team of specialists that can more effectively conduct audits of internal processes. In addition, a larger number of internal audits can be completed during any given year.

In making this award, Finance recommends JAA consider utilizing the State of Florida's competitively awarded contract with accounting firm, RSM US LLP. JAA has used RSM in the past for both internal and external audit services. Audit fees can vary depending on the size and complexity of the audit. Finance anticipates an average of \$55,000.00 for each audit, with a maximum of three audits per year, for a total of \$165,000.00. Finance also requests an additional \$35,000.00 for unforeseen additional audit requests, for a total of \$200,000.00. The remaining term of the State Contract expires February 28, 2025, with an additional one-year renewal option, and Finance is seeking approval to utilize any future applicable renewals, not to exceed five years, based on State of Florida Contract No. 84111600-20-1, Financial and Performance Audits.

### **RECOMMENDATION:**

Finance recommends that JAA utilize State of Florida Contract No. 84111600-20-1 to make a properly noticed award, pursuant to §§ 2.05(A)(12) and 3.08 of the Procurement Code, to RSM, LLC, for financial and performance audit services on an "as-needed" basis, in a total potential not-to-exceed amount of \$200,000.00. Funding is budgeted within Cost Center 31001.

### **BACKGROUND:**

In July 2024, the Awards Committee approved JAA Award No. AC2024-07-06 for Federal Mitigation Credits for the Arnold Road Canal Project to be awarded to Roberts Land & Timber Investment Corp *dba* Longleaf Mitigation Development Company, LLC in response to JAA-IFB-24-001M.

As of December 1, 2024, Engineering & Facilities has not received the permit from the Army Corps of Engineers and, for transparency, has received approval from Longleaf Mitigation Development Company, LLC to reserve the credits for use by JAA and re-assignment to any adjacent project within the basin. The purpose of this award is to remain transparent regarding the usage of the Federal Wetland Credits procured from JAA-IFB-24-001M and were specifically slated for use on the Arnold Road Canal project.

Federal Wetland Credits must be assigned a project permit and, since no permit has been assigned, JAA has verified the credits are transferrable to any adjacent project within the same basin. Engineering & Facilities, Procurement, and Finance have collaborated to ensure that Purchase Order No. 58973 and any future purchase orders reflect the correct project cost center once the permit is assigned.

#### **RECOMMENDATION:**

Engineering & Facilities recommends that JAA Award No. AC2024-07-06 be amended to allow the purchased Federal Wetland Credits referenced therein and in response to JAA-IFB-24-001M be reserved for usage on any applicable project within the mandatory requirements upon receipt of a permit from the Army Corps of Engineers. ### **BACKGROUND:**

On June 24, 2024, the Jacksonville Aviation Authority (JAA) approved JAA Award No. AC2024-06-09 to Jax Rims and Tires, LLC, for mobile vehicle window tinting for fleet vehicles and equipment.

### **BACKGROUND:**

The usage rate of Siemens High-Speed Diverters (HSD) installed at the Jacksonville International Airport (JIA) has increased exponentially with the TSA-mandated Round Robin software randomizing baggage delivery to the in-system scanners. Inaugurated in 2006, these HSDs have reach end of life and are two generations behind current systems. The Round Robin protocol creates increased stress for the HSDs and related components, potentially impacting system reliability. This, in addition to increased passenger traffic, has negatively impacted the baggage handling system, resulting in reduced reliability and increased maintenance requirements.

In November of 2023, the Jacksonville Aviation Authority's (JAA) Awards Committee approved JAA Award No. AC2023-11-07 for Phase I of JIA's HSD replacement. Engineering & Facilities requests authorization to proceed with Phase II of JIA's baggage handling system HSD replacement. Given the age and condition of the diverts, Siemens Logistics, LLC, the original equipment manufacturer, recommends these upgrades be completed to increase reliability while reducing overall maintenance costs.

### **RECOMMENDATION:**

Engineering & Facilities recommends JAA Award No. AC2023-11-07, awarded to Siemens Postal, Parcel, & Airport Logistics, LLC, for the purchase of and installation of Baggage High Speed Diverters at Jacksonville International Airport-Phase 1, be amended to: (i) add scope of services for Phase 2; and (ii) increase the award by \$182,968.00, for a new total potential award amount of \$346,934.00. Funds are budgeted within Capital Project J2024-06.

### **BACKGROUND:**

The Jacksonville Aviation Authority (JAA) has a need to provide valet parking services to the traveling public at Jacksonville International Airport (JAX). On September 30, 2024, the Valet Parking and Concession Agreement expired between the Jacksonville Aviation Authority (JAA) and SP Plus Corporation. The agreement is currently in month-to-month holdover status.

On September 23, 2024, Procurement advertised Request for Proposals (RFP) No. 24-19-43605 for Valet Parking Services to contract with a qualified firm that can proficiently manage and operate a Valet Parking Service Concession seven days a week, 365 days per year.

On November 4, 2024, JAA received two conforming proposals which were evaluated and ranked as follows:

1	SP Plus Corporation	86.21
2	Parking Veterans	82.42

#### **RECOMMENDATION:**

Business Development / Parking recommends an award be made to SP Plus Corporation, the higher ranked of the two respondents in response to RFP No. 24-19-43605, for valet parking services. The Minimum Annual Guarantee (MAG) for Contract Year 1 will be \$675,000.00 (first 12-month period after contract execution). The MAG for Contract Years 2 through 5 will be the greater of SP+Corporation proposed MAG for Contract Year 1 or 75% of the aggregate Privilege Fees due and payable for the prior Contract Year, whichever is greater. The Percentage Fees to be applied to Operator's Gross Revenues beginning on the Commencement Date shall be 20%.

### **BACKGROUND:**

In July 2024, Jacksonville Aviation Authority (JAA) Awards Committee approved AC2024-0713. Information Technology has identified that the Sourcewell Contract #70121-JHN includes coverage for equipment and maintenance of the Victor Video Edge video surveillance system. This is a critical system to the JAA, important to situational awareness and passenger safety. To keep this system operational, the NVR (network video recorder) storage needs to be replaced as the current storage is at end of life.

Johnson Controls provides this equipment through the Sourcewell Agreement Contract #70121-JHN, a valid purchasing vehicle for the JAA, for \$1,332,961.52. Information Technology also recommends an additional \$15,000.00 be included for unanticipated parts or other needs, for a total potential not to exceed award amount of \$1,347,961.52.

### **BACKGROUND**

In April 2024, the Jacksonville Aviation Authority (JAA) utilized Omnia Partners Contract No. R201203 to make an informal to Best Buy for audio visual equipment accessories and services on an as-needed basis throughout JAA's airport system. The informal award up to \$24,999.99 did not require Awards Committee approval, only a public notice posting.

JAA's airport system continues to have a need for audio visual equipment accessories and services on an as-needed basis, Contract spend analysis indicates the approved spending authority will reach depletion.

Pursuant to Sections 2.05(A)(12) and/or 3.08 of JAA's Procurement Code, Procurement's initial and current review of Omnia Partners Contract No. R201203 reveal that it remains favorable and continues to meet JAA's needs for such purchases. As such, Procurement is of the opinion that it is still in JAA's best interest to continue piggybacking this contract, which was competitively awarded to Best Buy.

To continue providing seamless on-line and instore purchases through contract expiration, Procurement requests authorization to increase the total award amount by \$50,000.01 to cover future purchases by all JAA departments.

### **BACKGROUND:**

The Jacksonville Aviation Authority (JAA) purchases and stocks supplies needed for Access Control such as access / proximity cards, ribbon cartridges, and badge holders and clips, among other necessary items that are critical for safety and security. Items like proximity cards are specific to JAA and must be purchased with certain specifications and coding to maintain security.

On December 2, 2024, JAA received bids in response to Invitation to Bid 25-02-17111 for Access Control Supplies. One responsive bid was received from IRIS Ltd Inc. Inasmuch as IRIS is the incumbent in good standing, the Storeroom and Procurement are of the opinion that resoliciting this matter is not necessary. The contract term for this solicitation is five years.

Based on historic spend, future growth and unit pricing over the five-year term, Procurement and Access Control estimate the need for \$325,000.00. This estimate is supported by anticipation of increase in passenger traffic, airport expansion, and inventory needs to maintain security.

#### **RECOMMENDATION:**
